Registration Deadline: Friday, Sep. 6 (09/06), 2024

Any suspension or withdrawal application made after the registration deadline will be charged at the prescribed rate. (please refer to the [related application forms](#).)

Attention: Under STUST Academic Regulations, students shall be dismissed if they fail to complete the registration (tuition payment) before the registration deadline.

- 2) Pay in Cash at the following institutions

 - b. 7-11/Family Mart/Ok. Mart (for bills under NT60,000)
Hi-Life (for bills under NT40,000)
 - c. Any Banks in Taiwan (processing fees will be charged which may vary in different banks)
