

【STUST Announcement】

In-Person and Remote Learning Weekly Rotation Measures will be Implemented in 2 Stages: **First-Year Students Start from Sept. 27; Other Students from Oct. 4.**

1. Two Stages

(1) From September 27 (4th week)

1st-year students (including 1st-year graduate school students) start to take turns returning to campus for in-person learning.

(2) From October 4 (5th week)

2nd -year and higher year level students take turns returning to campus for in-person learning.

2. Implementation Methods

(1) In-person and Remote Learning Rotation:

For courses with more than 30 students enrolled, students will be divided into two groups in accordance with the last digit of their student number, and rotated to attend classes in-person and remotely on alternate weeks as below.

Last Digit of Student No.	In-Person Class Attendance
Even (0、2、4、6、8) 12345678	Even weeks: 4th week (9/27~10/1)、6th、8th、 10th、12th、14th、16th、18th week
Odd (1、3、5、7、9) 87654321	Odd weeks: 5th week (10/4~10/8)、7th、9th、11th、 13th、15th、17th week

(2) In-person Class Attendance:

For courses with less than 30 students enrolled, students should attend classes in-person. If lecturers deem that rotation of in-person and remote learning is necessary, in-person class attendance could be changed to the preceding rotation measures.

3. Maintain Status Quo

If the lecturers have already adopted rotation measure or in-person learning since the lecture started, students should maintain status quo, however, the dispersion should follow the rotation policy: students will be divided into two groups in accordance with the last digit of their student number, and rotated to attend classes in-person and remotely on alternate weeks.

4. Students who should attend classes in-person will be marked in the roll call system.

5. Inquiry about related information

6. On-site classes must follow the epidemic prevention regulations:

staying 1.5 meters apart, wearing a face mask all the time, no food and drink is allowed, disinfecting periodically, maintaining air flow (every window in the classroom should maintain 15 centimeters opened), etc.

7. Current students who require remote learning due to special reasons should submit application under the Study-at-Ease measures. After the approval by the lecturer and the curriculum office, students can maintain remote learning until the special reason is removed.

New students who haven't arrived at STUST nor reported to Registration Office to complete the registration procedure will be automatically marked as Study-at-Ease students. However, after the quarantine and self-management, if new students require remote learning due to special reasons, they should submit application as well.

8. Lecturers who require remote teaching due to special reasons should submit application under the Study-at-Ease measures. After approval, the lecturers could adopt remote teaching until the special reason is removed.

9. The implementation will be adjusted on a rolling basis in accordance with the epidemic situation. Please check homepage for the latest news often.
